- O If you disagree with this decision, you may appeal to the Minister of Justice within 30 days after the final day of the notification period pursuant to Article 21(1) of the Refugee Act, or file an administrative appeal within 90 days from and including the date on which the decision was notified or within 180 days after the date on which the notification period expired pursuant to Article 27 of the Administrative Appeals Act. However, pursuant to Article 21(2) of the Refugee Act, you may not file an administrative appeal regarding this decision if you have already appealed to the Minister.
- O If you disagree with this decision, you may also file an administrative litigation in court within 90 days from and including the date on which the decision was notified or within one year after the date on which the notification period expired pursuant to the Administrative Litigation Act.
